11. First aid measures

Eye contact: Dust particles: Do not rub. Rinse carefully with water for several minutes. Remove contact lenses if present. Continue rinsing. If irritation or rash occurs: Seek advice/consult a doctor.

Ingestion: Seek medical advice/assistance.

13. Storage and handling: Store on a flat surface, in a clean and dry place, away from direct sunlight. Keep away from heat, sparks, open flame, and other ignition sources.

- Skin protection: Protective gloves against mechanical hazards (EN 388)
