## Eurovent **SUPPORT DECRA 20**

### **Application:**

The one-piece adapter Eurovent SUPPORT DECRA 20 is designed for use as a roof communication element for efficient installation of the Eurovent<sup>®</sup> PLATFORM chimney platform or the Eurovent<sup>®</sup> STEP chimney step on a roofing made of profiled concrete or ceramic tiles. When installing the chimney platform, the universal grip Eurovent<sup>®</sup> GRIP must be also used.

### **Fitting:**

The set is installed directly to the roof construction on the batten by means of screws.

### **Storage / transport:**

The product should be stored under roof in dry, damp-free rooms, protected from direct UV radiation. Product can be deformed, disfigured or suffer from damages of galvanized/paint coating if put under high pressure. Therefore it is unadvised to stack the product with other heavy products (both in storage and in transport). It is recommended to transport the product with use of covered means of transport, in manner that protects them from damage. During the transport safety regulations have to be observed. The product should be protected from chemical agents, in particular solvent-based substances, as they can reduce technical parameters of the product or permanently damage it.
